Terms and Conditions

Booking Conditions :

1. General - Bookings are arranged between holidaymakers ('The Holidaymaker') and the owner of Corraith Holiday Cottage, Mrs Beverley Earnshaw ('Mrs Earnshaw').
2. Contract - A binding contract between the Holidaymaker and Mrs Earnshaw shall be entered into on Mrs Earnshaw issuing the Holiday Confirmation of Booking Form.
3. Payment - Bookings and reservations shall only be negotiated by Mrs Earnshaw on payment of a non-returnable deposit of £50. The balance shall be payable six weeks before the commencement of the holiday. Receipt of any deposit shall not constitute acceptance of any booking.
4. Cancellation - Any cancellation made by the Holidaymaker, for whatever reason, shall be in writing addressed to Mrs Earnshaw at the address shown on the top of the booking form. On receipt of such notice Mrs Earnshaw shall endeavour to re-let Corraith Holiday Cottage for the entire period of the original booking. If Mrs Earnshaw is successful in re-letting Corraith Holiday Cottage, Mrs Earnshaw shall refund all monies paid for the period which has been re-let, less the deposit of £50 per week booked.
5. Limitation of Liabilities - The use of the accommodation and the amenities at Corraith Holiday Cottage is entirely at the Holidaymaker's own risk. Neither Mrs Earnshaw, nor her employees nor agents, shall be under any liability to the Holidaymaker or to third parties, for any injury, or for any loss or damage to the Holidaymaker's belongings, howsoever arising. No responsibility can be accepted for loss or damage to any car or its contents.
6. Number of People - The number of people using Corraith Holiday Cottage shall not exceed 8 persons.
7. Pets - are welcome by prior arrangement.
8. Access - Mrs Earnshaw or her representatives shall be allowed access to Corraith Holiday Cottage at any reasonable time during holiday occupancy.
9. Repair - The Holidaymaker undertakes to keep the premises and all furniture, fixtures, fittings and effects in or on the premises in the same state of repair and condition as the same are at the commencement of the letting (reasonable wear and tear excepted). Any damages should be reported to the owner and a replacement/repair charge may be levied.
10. Arrival and Departure - Corraith Holiday Cottage may not be occupied before 3 pm on the day of arrival and must be vacated before 10 am on the day of departure.
